### GCI to Participate in International Planning Course

In partnership with Radboud University Nijmegen, Blekinge Institute of Technology and Cardiff University, the Great Cities Institute will take part in a joint Erasmus Mundus Master Course in European spatial planning, environmental policies and regional development named PLANET Europe. GCI's engagement will primarily take the form of guest lectures on urban political economy, regionalism and economic development, and enabling study visits by students and lecturers in the program.

### GCI Begins Training Program on Sustainable Fund Development

The Certificate in Sustainable Fund Development (CSFD) training program, GCI's newest nonprofit management and capacity building effort, is part of a collaboration between GCI's Professional Education Program and Illinois ResourceNet. Co-directed by Thea Crum and Kate Pravera, CSFD provides free training and one-on-one coaching to seven community based nonprofit organizations in Homan Square, Humboldt Park, and the Near West Side. The program will work with these organizations over the next year to develop sustainable fund development plans and organizational systems that will support their successful implementation. CSFD is generously funded by the City of Chicago TIF Works program.

*Faith-based HIV prevention with African American mothers and daughters*

### Research Summary

Dr. Chisina Kapungu's research is focused on the development and evaluation of culturally-sensitive HIV prevention programs for high-risk populations. She has received a number of research awards. Dr. Kapungu is currently conducting qualitative research focused on identifying and defining psychosocial determinants for engagement in concurrent partnerships among men and women in Zimbabwe. Her long-term goal is to develop and disseminate culturally sensitive HIV primary and secondary prevention programs in the United States and Sub-Saharan Africa.

### GCI Faculty Scholar Gives Talk at Ohio Supreme Court

Dr. Larry Bennett, GCI Faculty Scholar and UIC Professor of Social Work, presented an invited talk on November 17, 2011 in Columbus, Ohio at the annual Specialized Dockets Conference of the Ohio Supreme Court. Bennett discussed the preliminary findings from his collaborative GCI project and general issues of integrating criminal justice and community-based interventions for co-occurring substance abuse and domestic violence. He and his team member, GCI Faculty Scholar Stephanie Riger, are currently engaging in their GCI project at the Cook County Domestic Violence Court.
