### Faculty Scholar Spotlight

#### Naoko Muramatsu

UIC School of Public Health



#### "Caring for Limited English Speaking Elderly: The Roles of Ethnic Social Service Agencies in a Global City"

In her public lecture on March 1, 2011, Naoko described how global cities have become "homes away from home" for a growing number of aging immigrants. Paid care givers play increasingly important roles in the lives of limited English speaking elderly as they experience declining physical and cognitive function. As employers of those caregivers, ethnic social services agencies serve as cornerstones of urban immigrant communities. Professor Muramatsu discussed how such organizations contribute to the well-being of aging immigrants in Chicago with implications for the long-term care system in the U.S. She argued that coalitions of these ethnic organizations provide Chicago with a strong foundation for becoming an aging-friendly global city.

#### BIO

Professor Muramatsu's research focuses on health and aging, access to and quality of health services, policies related to longterm care and services for older persons, long-term care workforce, and cross-cultural analysis. ### GCI Comparative Urbanisms Lecture Series: "Millennium Park's Future in the Post-Daley Era"

Presented by: Edward K. Uhlir, FAIA Executive Director, Millennium Park Inc President, Uhlir Consulting



Thursday, March 10, 2011 3pm - 4:30pm @ GCI, CUPPAH 400

Ed Uhlir will explore Millennium Park's future by explaining its creation, its successes, and the factors that will affect its continued prosperity. In particular, he will discuss the history of the park site, the Mayor's vision, the involvement of various artists, architects and landscape designers, and the public/private financing model pioneered there. This background information provides the foundation for thinking about the Park in a post-Daley era. How will the Park be maintained, what kinds of programming should take place there, and what kinds of economic impacts will it have?

Ed Uhlir was the Director of Research and Planning at the Chicago Park District until his appointment in 1998 by Mayor Richard M. Daley as the Director of Design of the Millennium Park Project. He is a consultant and President of Uhlir Consulting LLC and the Executive Director of Millennium park Incorporated (MPI). He also is an Adjunct Professor of Architecture at Illinois Institute of Technology, Chicago, the Secretary of Neighbor-Space, a land trust for community gardens, a member of Mayor Daley's Parks and Open Space Committee, and a board member of the City Parks Alliance.

#### Claire Decoteau UIC Department of Sociology



"HIV/AIDS and the Struggle for Life in South Africa's Slums"

#### Public Lecture March 15, 2011 @ 2pm

People living in urban slums in contemporary South Africa have the highest rates of tuberculosis and HIV/AIDS in the country. Their abject poverty and lack of access to nutritious food sources, clean water, and sustainable housing contribute to poor health. Drawing on extensive ethnographic research conducted in informal settlements on the outskirts of Johannesburg and analysis of the politics of AIDS in South Africa from 1994 through 2010, Claire will argue that HIV/ AIDS policy has been a venue through which the South African government has attempted to balance contradictory demands of post-colonial nation-building: forced to satisfy the demand of neoliberal global capital and to meet the needs of its desperately unequal population.

### GCI Stukel Professor Michele Kelley Gives Distinguished Lecture on Collaborative Inquiry

This past month GCI Stukel Professor Michele Kelley was invited to present at the University of South Florida's (Tampa) College of Behavioral and Community Sciences. During her presentation titled "Developments in Collaborative Inquiry

to Foster Community Well-being and Equity," Michele discussed her ongoing work on innovations in Community-Based Participatory Research (CBPR) and the challenges that exist with roles of community and university partners in joint inquiry to enhance community well-being. In addition, she explored collaborative inquiry as it relates to community development and cultural renewal, and the connections to traditions in the social justice foci of social work and public health. A new conceptual framework for capturing the process of change was introduced. Attendees were from various departments at USF as well as from community based organizations. In addition to getting a break from Chicago's winter, Michele renewed friendships with long time colleagues and pursued discussion over lunch in one of Tampa's historic neighborhoods.

### **Rachel Weber Discusses Sweet Home Chicago Ordinance**

Medill Reports quoted Associate Director for Research and Program Development Rachel Weber regarding the Sweet Home Chicago Ordinance that failed to come to a vote in early February. The ordinance proposed to designate 20% of revenue collected through the TIF program to build affordable housing. Weber described how ordinances like this are necessary for people to express their opinion on how TIF funds are deployed in as centrally controlled a TIF program as Chicago's; she also discussed the challenging mechanics of TIFs; for example, the "underlying mechanism of TIF works very well when there is a big spike in property values, and with affordable housing you're likely to get an increase, but the increment probably won't be as much as if you put in market-rate development or some form of commercial development." In an article on the heavy effect of the foreclosure crisis in increasing the number of vacant homes in the Chicago suburbs since the last census of 2000, the Daily Herald newspaper quoted GCI Fellow Phil Ashton as saying that the hardships of the economic recession, as seen through the foreclosures crisis, are likely temporary and "those who lost their homes could have a chance at ownership again in the next five to seven years."
