"Mapping Architecture's **Social Entrepreneurial** Networks"

Faculty Scholar Seminar Feb 1 @ 2pm

In her seminar, Sharon will discuss how the development of a "networked public sphere" (Yochai Benkler) is producing new forms of social entrepreneurship in architecture that are reviving, extending, and transforming community-based architectural practices initiated in the 1960s. Capable of mobilizing large numbers of architects across the globe for direct action on the ground in cities as diverse as Biloxi, Mississippi and Port-au-Prince, Haiti, these networked organizations are building new linkages between architects and potential clients, designers and NGOs, human needs and community capacities. Sharon will explore how networkbased technologies are transforming design-based movements and will outline a framework for assessing the productivity and sustainability of these practices.

Sharon's research and teaching focuses on urban design and theory, schools and urban development, globalization, and housing design. Her book The City As Campus: Urbanism and Higher Education in Chicago has just been published by the University of Minnesota Press. Forthcoming publications include "Heritage and Sustainability in Shunde (China)" in Heritage Cities, Heritage Sites (Springer) and a commissioned essay for the ->

In the first seminar of the Spring 2011 GCI Comparative Urbanisms Series, Professor Bennett will discuss his new book The Third City: Chicago and American Urbanism, which examines a variety of Chicago literature, interprets the mayoralty of Richard M. Daley, and reconsiders one of Chicago's core identities—the city of neighborhoods. This talk will focus on one of the book's principal themes, Chicago's self-consciousness, and will further explore how this variously expressed local attribute often distorts our perception of the emergent Chicago.

Dr. Bennett's research focuses on city planning, redevelopment, neighborhood issues, and contemporary Chicago politics.

The Urban Planning and Policy Student Association at the University of Illinois at Chicago will hold the first annual Urban Innovation Symposium. A three–part, day–long event, the symposium will bring together a diverse group of pioneering professionals for a series of interactive discussions and presentations on recent innovations in their respective fields, includ-

ing community art, urban agriculture, public health, sustainable development, urban food systems, and alternative transportation.


During the symposium's opening session, a panel of five notable professionals will deliver short presentations on their work. Following these presentations, the panel members will hold individual hour—long breakout sessions with the symposium's attendees. Attendees will choose one breakout session to discuss creative solution to urban challenges. A final session of presentations will be delivered later that evening at Work Studio in Logan Square, by a new round of emerging innovators. Using the PechaKucha format, these visually oriented presentations will be approximately 7 minutes in length. Rachel Weber on TIF and Job Creation

GCI Associate Director Rachel Weber was quoted in the *Chi*cago Reporter this month regarding the tendency of Chicago alderman to value construction over job creation in projects subsidized by municipal incentives. Between 2004 and 2008 the Loop and the Near South community accounted for 55 percent of all TIF money spent within the city, spurring considerable development within the downtown area. Despite the investment of public money the Loop lost 12,296 jobs, with city residents' accounting for 94 percent of the lost employ-

Rachel Weber on TIF and Schools

Several Chicago mayoral candidates favor the notion of extending the school day to improve education, but are faced with the task of locating funding to pay for the increased instruction time. Quoted by the Chicago News Cooperative, GCI Associate Director Rachel Weber discussed the advantages of funneling tax increment financing funds into the schools after a TIF district has served its purpose in order to help solve the problem of school funding. Rachel Weber on TIF and Affordable Housing

In an article discussing the Sweet Home Chicago proposal stalled before city council that would devote 20 percent of all development cash from Tax Increment Financing toward creating of affordable housing, the Chicago Journal quoted GCI Associate Director Rachel Weber on the dynamics of TIF and its dependence on rapid spikes in property values to support it. The Medill Reports quoted GCI Associate Director Rachel Weber on the use of TIF money to fund smaller scale projects, in particular a retail complex in Albany Park named Thai Town Center. Weber discussed the ramifications of TIF money morphing into "an all-puspose general development subsidy," which in turn could distance TIF from its legal purpose. Get the full story here.
