Confronting Homelessness in the Suburbs

A quintessential urban problem, homelessness in the suburbs seems unreal. However, as in the City of Chicago, thousands of homeless individuals seek shelter and services across the region's suburbs. Unlike urban areas, many suburban areas lack a concentration of social services and resources necessary to effectively serve the growing homeless population and in the end to eliminate homelessness. Growing in number and in strength suburban human services organizations have been banding together to better respond to this growing problem. CUPPA's Charlie Hoch will respond to the panel with his analysis of responses to homelessness.

Charlie Hoch is a professor of urban planning & policy at the University of Illinois at Chicago. Hoch's early professional experience consisted mainly of environmental land planning working as regional planner. After moving to Chicago he turned his attention to the then emerging problem of urban homelessness. Working with social researchers from several non profit groups he set out to trace the roots of contemporary homelessness to the slum and ended up discovering the value of the hotel as an urban resource for the single poor. This insight set in motion several decades of research on homelessness, affordable housing and informal helping.
